ARRL Field Day Rules 2021

- **4.5.** (Class C) Mobile: Stations in vehicles capable of operating while in motion and normally operated in this manner. This includes maritime and aeronautical mobile. If the Class C station is being powered from a car battery or alternator, it qualifies for emergency power but does not qualify for the multiplier of 5, as the alternator/battery system constitutes a motor-driven generating system.
- **4.6.** (Class D) Home stations: Stations operating from permanent or licensed station locations using commercial power. Class D stations may only count contacts made with Class A, B, C, E and F Field Day stations.

<u>Temporary rule waiver</u>: For Field Day 2021 only, Class D stations may work all other Field Day stations, including other Class D stations, for points. Field Day rule 4.6 defines Class D stations as "Home stations," including stations operating from permanent or licensed station locations using commercial power. Class D stations ordinarily may only count contacts made with Class A, B, C, E, and F Field Day stations, but the temporary rule waiver for 2021 allows Class D stations to count contacts with other Class D stations for QSO credit.

For 2021, Class D and Class E stations are limited to 150 W Peak Envelope Power (PEP) transmitter output.

- **4.7.** (Class E) Home stations Emergency power: Same as Class D, but using emergency power for transmitters and receivers. Class E may work all Field Day stations. See 2021 power limitation above.
- **4.8.** (Class F) Emergency Operations Centers (EOC): An amateur radio station at an established EOC activated by a club or non-club group. Class F operation must take place at an established EOC site. Stations may utilize equipment and antennas temporarily or permanently installed at the EOC for the event. Entries will be reported according to number of transmitters in simultaneous operation. Class F stations are eligible for a free VHF station. At Class 2F they are also eligible for a GOTA station.

ARRL Field Day Rules 2021

If we are able to have Field Day at the Aldrich Field the general FD rules will apply. However, Class C, D, E and F stations may still be operated away from the field and have their scores aggregated with the Club overall scores as per ARRL:

Temporary rule waiver: For Field Day 2021, an aggregate club score will also be published, which will be the sum of all individual entries indicating a specific club (similar to the aggregate score totals used in ARRL affiliated club competitions). Ordinarily, club names are only published in the results for Class A and Class F entries, but the temporary rule waiver for 2021 allows participants from any Class to optionally include a single club name with their submitted results following Field Day. For example, if Podunk Hollow Radio Club members Becky, W1BXY, and Hiram, W1AW, both participate in 2021 Field Day -- Hiram from his Class D home station, and Becky from her Class C mobile station -- both can include the radio club's name when reporting their individual results. The published results listing will include individual scores for Hiram and Becky, plus a combined score for all entries identified as Podunk Hollow Radio Club.
